

The disabled people who work with Rica have similar issues - for example people who use sign language translators.

#### **DRILL** – research funding opportunities for DEEP groups

A funding initiative with £5million Lottery monies has put out a call for research project proposals. Disability Research on Independent Living and Learning (DRILL) is supported by Disability Rights UK, and similar rights focused organisation in Wales, Scotland and Northern Ireland and specifically mention people with dementia as being included.

The amounts offered are:

- Small research grants up to a value of £40,000 each (1 stage process)
- Large research grants up to a value of £100,000 each (2 stage process)
- Pilot projects up to a value of £150,000 each (2 stage process)

Deadline for small grant applications and first stage large grant and pilot project applications is 27th July 2016.
